Comment

CPRENorthYorkshire welcomes the further opportunity to comment on the above major application at land north of Westfield Road, Tockwith.

CPRENorthYorkshire previously commented on a proposal by the developer to construct 61 new dwellings and 1 agricultural conversion to a dwellinghouse at the application site in May of this year. CPRENorthYorkshire are disappointed that the applicant has chosen to amend the proposals for an even larger scheme despite numerous concerns having been made by members of the community, statutory consultees and this charity.

CPRENorthYorkshire, therefore, maintain their objection to the proposals in the current guise and ask that the Council consider both this letter and our previous response dated 24th May when determining this application.

CPRENorthYorkshire were disappointed that the applicant did not submit a planning statement with the amended plans identifying any 'need' for the additional dwellings at this location or addressing concerns that had been raised previously in policy terms.

Furthermore, the revised plans do not appear to have addressed concerns regarding heritage assets in the immediate vicinity of the site and the Conservation Area.

The applicant appears to be reliant on the fact that the site is identified in the emerging Local Plan for an approval and has not justified the design and layout of the proposals adequately. CPRENorthYorkshire believe that the proposals remain in conflict with the development brief set out in that document (as previously stated) and the Council's Conservation Area Character Assessment.

CPRENorthYorkshire would wish to be kept informed with the progress of this application and reserve the right to submit additional comments should further information be submitted.
